NOTIFICATION

In public interest and in supersession of all previous notifications and orders in this regard and in exercise of the powers conferred by Sub-section (1) of Section 3 of the Tripura Land Revenue and Land Reforms Act, 1960 (43 of 1960), the Governor of Tripura is pleased to create one new Sub-Division namely Santirbazar Sub-Division with headquarters at Santirbazar altering the limits of Belonia Sub-Division of South Tripura District, Tripura. The jurisdiction of the new Santirbazar Sub-division shall comprise the areas as indicated in the schedule below.

2. After creation of the Santirbazar Sub-Division, the re-organised Belonia Sub-Division will comprise the area as indicated in enclosed Annexure-A
3. The new Santirbazar Sub-Division, shall start functioning from such date as may be fixed by the Government.
4. The new Santirbazar Sub-Division shall be under South Tripura District.
