**MEMORANDUM**

**Sub: Seeding of Aadhaar in the Record of Rights(RoR).**

Government in the Revenue Department has taken decision that Aadhaar number shall be linked with the Khatian of landowners throughout the State under NLRMP as per proposal of the MoRD, DoLR, GoI. All SDMs shall direct the Tehsilders to collect Aadhaar card number of the recorded land owners alongwith photocopy of the same.

Mouja wise downloadable format has been designed and linked with CLR Database. System will allow all authorized CLR officials to download the format in MS Word & Excel. Concerned CLR shall download moujawise Aadhaar format and send the print copies to TK Offices(a sample copy enclosed at annexure-I). Operational guideline for downloading of format is enclosed at Annexure-II. All Tehsil offices shall collect mouja wise Aadhaar numbers as per format.

Concerned DCMs shall verify the correctness of Aadhaar Card number and allow for incorporation of the correct numbers against the concerned Khatians of the recorded landowners in CLR database subsequently in another software module to be prepared by NIC. Tehsil offices shall start the work of collection of Aadhaar number w.e.f. 21<sup>st</sup> December 2015, after wide publicity in T.K. area for proper awareness of the citizens.
