MEMORANDUM

This is for information to all that the Government in the Revenue Department in cooperation with Ministry of Agriculture & Farmers Welfare, Department of Agriculture, Cooperation and Farmers Welfare, Government of India has undertaken Agriculture Census as a Land Records State. 175 revenue villages (EARAS) have been selected for the survey on taking land records base methodology. A pilot study has already been taken up under Sadar and Mohanpur Sub-Divisions of West Tripura District.

2. List of 175 Revenue villages falling under EARAS is enclosed herewith for information of all concerned.

3. As per guidelines of Agriculture Census, Enumerators and Supervisors are required to be appointed from Tahsildar / Amin / Agri. Assistant / VLW and Agri. Officer / Agri. Extension Officers / Revenue Inspector respectively.

4. All the DM & Collectors are requested to advise the concerned Sub-Divisional Magistrates to appoint one each Enumerator for each of the revenue villages. One Supervisor may be appointed for maximum 3 or 4 revenue villages. The Sub-Divisional Magistrates may also be advised to endorse a consolidated list of appointments made by them in this regard to the office of the undersigned in order to facilitate the office to chalk out training programme, if necessary, at the district level as also to give them guidelines and survey materials during the such training. The period of survey should be completed in all respect between July and August, 2016.


