Sub:- Requirement of ETS Survey knowing staff for smooth  
running of Revisional Survey Operation.

Sir,

With reference to your letter No.F.7(20)/SDM/GNC/REV/2010/208, dated 03/07/2014 on the subject mentioned above, I am to inform you that 4 to 5 persons having knowledge on ETS/GPS may be engaged purely on temporary basis for 1(one) year at a remuneration of Rs.8,000/- (eight thousand) only per month from local unemployed youth. Engagement may be made from outside Sub-Division at a remuneration of Rs.10,000/- (Ten thousand) only per month, if engagement is not possible from local people due to unavailability of ETS/GPS literate. It may be mentioned that a good number of educated youths have got training and acquired knowledge on ETS/GPS from the RSTI, A.D.Nagar. A list of the ETS/GPS training holders at RSTI is enclosed herewith as ready reference.

Further, as the helping hand you may engage 2 persons of Group - D category against each deployed ETS team on purely temporary basis at a monthly remuneration of Rs.5,000/- (Five thousand) only per month for one year.

Necessary assistance will be provided by the technical staff of the DLRS Office for starting up the work of ETS survey. Rest office staff will also be deployed from DLRS office for which order will be issued soon.

Payment for the engagement may be made from the Survey/Re-Survey component of NLRMP which has been allotted to the DM & Collector, Dhalai District from time to time. Priority may be attached for engagement from local people.

An advertisement for engagement of ETS literate may be published in local Newspapers by SDM and the same will be uploaded in <http://jami.tripura.gov.in> / [tripura.gov.in](http://tripura.gov.in) from this Directorate by SA.
