**MEMORANDUM**

**Sub: Seeding of Aadhaar in the Record of Rights(RoR).**

It has been decided by the Government in the Revenue Department that Aadhaar number shall be linked with the Khatian of landowners throughout the State under NLRMP as per proposal of the DoLR, MoRD, GoI. All SDMs were directed to arrange collection of Aadhaar number of the recorded landowners alongwith photocopy of the same vide No. F. 6(398)-DLRS/DE /2007/13866-949 dt. 16<sup>th</sup> December 2015(copy enclosed for ready reference).

2. In this regard, two tier software module has been designed. The first-tier of the module is for data entry of Aadhaar number of the landowner by ensuring that the security of land records' database is not compromised apart from the existing Revenue Staff. The SDMs may engage private contractual manpower also for incorporation of Aadhaar number in the respective CLR centres under their control in expeditious manner and for this purpose, one time financial assistance shall be provided from the Directorate of Land Records & Settlement in the manner indicated in the Annexure enclosed herewith. The second tier of the module requires prior authentication of Aadhaar number at RI/DCM level before it is finally incorporated in the computerized land records database. RIs/DCMs shall be advised to take due care during authentication process.

3. All SDMs shall provide the names and Mobile No. of contractual operators to the DLRS through emails at [lrcomplain@gmail.com](mailto:lrcomplain@gmail.com)/[dls.tripura@yahoo.in](mailto:dls.tripura@yahoo.in) for issuing User Id and Password. Existing CLR Operators shall also incorporate Aadhaar number in computerized Khatians. User manual with operational functionalities shall be downloaded from the website <http://jami.tripura.gov.in>
